

Surgical attire is for OR suites and OR like suites ONLY. All persons entering an OR or OR like suite must wear hospital provided surgical attire. (For purposes of this provision, the definition of OR like is as defined by The American Institute of Architect Guidelines and Centers for Disease Control and Prevention.) Surgical attire includes: hair and facial hair covering, scrub suit, mask, eye shield and dedicated operating room shoes or shoe covers.

The following areas are authorized to wear **MCG Health, Inc. LOGO scrub suits**:

1. *Misty green* **MCG Health, Inc. LOGO scrub suit** for Adult Peri-Operative Services, adult catheterization suites, Electrophysiology (EP) suites, Adult Interventional Radiology suites.
2. *Colbalt blue* **MCG Health, Inc. LOGO scrub suit** for CMC Peri-Operative Services, Pediatric Catheterization suite, Pediatric Interventional Radiology suite.
3. *Raspberry* **MCG Health, Inc. LOGO scrub suit** for Labor and Delivery, Post Partum and Newborn Nursery.

No other department or persons are authorized to wear MCG Health, Inc. logo scrub suits.

MCG Health, Inc. logo scrub suits are **prohibited** outside of the facility. (NOTE: for purposes of this policy, curbside patient pickup areas, and the VA Hospital, if accessed by the indoor connecting bridge, are considered to be within the hospital).
