PURPOSE

This course is designed to bring together the art and science of clinical and esthetic dentistry and will focus on many of the clinical issues we deal with in our daily practices from treatment planning to material selection to execution. Additionally, the effect of airway breathing disorder on occlusion and restorative treatment will be discussed. This program promises to provide a potpourri of clinically relevant topics that we as clinicians can implement immediately into our practices to improve the quality of patient care and satisfaction.

OBJECTIVES

At the completion of this course, participants should be able to:

- Describe indications and contraindications for contemporary ceramic materials
- Describe which cements to use and which cements are to be avoided for cementing implant-supported crowns
- Identify when and how to perform direct pulp caps in vital teeth
- Recognize the clinical signs of chemical erosion at an early stage and implement the appropriate preventive strategies
- Recognize how the location and pattern of erosive tooth wear provides important clues regarding the specific etiology
- Implement specific prevention and treatment protocols for patients with bulimia and GERD
- Recognize and describe the importance of evaluation of the airway to occlusion, bruxism, and TMD
- Utilize facially generated treatment planning to visualize the proposed outcome for esthetic treatment
- Analyze and plan the occlusal scheme for healthy, predictable, and long-term function

Terence ("Terry") E. Donovan, DDS, received his D.D.S. from the University of Alberta in 1967, and practiced full time in Regina, Saskatchewan for 13 years. He received his Certificate in Advanced Prosthodontics from the University of Southern California in 1981 and was Professor and Director of the Advanced Education in Prosthodontics Program at USC from 1988 - 2006. He served as Associate Dean for General Practice and Executive Associate Dean for Academic Affairs at the University of Southern California, as well as the Chairman of the Department of Restorative Dentistry from 1984 - 1991, and 1994-2001. He is currently Professor and Section

Head of Biomaterials in the Department of Operative Dentistry at the University of North Carolina, School of Dentistry at Chapel Hill. He has published extensively, and has lectured world-wide on the topics of restorative dentistry and materials science. He is a member of numerous local, national and international dental organizations and is past Chairman of the American Dental Association's Council on Dental Materials, Instruments, and Equipment.



Gary M. DeWood, DDS, MS, lives in Phoenix with his wife of 40 years, Dr. Cheryl DeWood. A native of Toledo, Ohio, Gary earned his D.D.S. from Case Western Reserve University in Cleveland in 1980. He completed the University of Florida Facial Pain Center Curriculum from 1992 through 1995, and in 2004 he earned a Master of Science degree at The University of Toledo College of Medicine. He left full-time private practice in 2003 to serve as clinical director at The Pankey Institute, a position he held until

2008 when he joined Frank Spear in Seattle as the president of Dr. Spear's education company, The Seattle Institute. As a founding member of Spear Education, he relocated to Arizona in 2009 as Executive Vice-President for curriculum and clinical education. He maintains a limited private practice on the Spear campus, teaches in the Practice Solutions and Spear workshops, Spear Online, and in Spear Study Clubs
