DESCRIPTION

Modern restorative dentists have a fantastic array of materials to utilize for restorative treatment. The combination of traditional principles with modern materials has completely changed the way that complex cases are approached. Dr. McDonald will outline a system for diagnosis and treatment sequencing of complex restorative cases through segmental restorative treatment with modern materials. This approach is more technically achievable for the clinician and laboratory technician and certainly more feasible for the patient.
