HS 16.0 House Officer Moonlighting

1.0 Purpose

To establish guidelines for Department decisions concerning House Officers involvement in Professional Activities outside of the Educational Program (Moonlighting).

2.1 Procedure

2.2 House Officers at Augusta University may engage in Professional Activities outside the educational program (moonlighting) only with *prior written consent from the Program Director and Senior Associate Dean for Graduate Medical Education and VA Affairs* with a copy on file in the Graduate Medical Education Office and the House Officers Training file. (See attachment for moonlighting approval form)

Note: U.S. Code of Federal Regulations governing exchange visitor Programs allows an exchange visitor who holds a J1 Visa to receive compensation only for activities that are part of the designated Training Program. An exchange visitor who engages in unauthorized employment shall be deemed to be in violation of his/her program status and is subject to termination as a participant in an exchange visitor program. Moonlighting is strictly prohibited for J1 Visa holders.


Note: House Officers in HIB status may not work for other employers or in positions other than those described in the GUR HIB petition without applying for additional HIB sponsorship.

2.3 Even when permitted, House Officers must not be required to engage in moonlighting, because Residency education is a full-time endeavor. The Program Director must ensure that moonlighting does not interfere with the ability of the House Officer to achieve the goals and objectives of the education program.


2.4 All moonlighting that occurs within the Residency Program must be counted toward the 80-hour weekly limit on duty hours (ACGME Common Program Requirements VI.G.I).

2.5 All House Officers engaged in moonlighting must be licensed for unsupervised medical practice in the State where the moonlighting occurs. It is the responsibility of the moonlighting House Officer and the Institution hiring such a House Officer to determine whether such licensure is in place, adequate liability coverage is provided and whether the House Officer has the appropriate training and skills to carry out assigned duties. Augusta University liability insurance does not cover the activities of a House Officer while they are moonlighting.

2.6 The Augusta University requires that the Program Director acknowledge in writing that he/she is aware that the House Officer is moonlighting and that this information is made part of the House Officers folder and a copy is on file with the Graduate Medical Education Office.
