POLICY STATEMENT

Interlibrary Loan (Loansome Doc) is a fee-based service provided by the Robert B. Greenblatt, M.D. Library to assist non-Augusta University-affiliated health professionals and individuals located in the Central Savannah River Area (CSRA) and the State of Georgia in rapidly obtaining documents identified through PubMed searches. This policy defines what is covered by the service, who is eligible to receive the service, and the means and conditions under which documents are delivered.

The Robert B. Greenblatt, M.D. Library serves as the public health sciences library of the State of Georgia. It provides access to a virtual library of online journals, databases, and other resources in addition to its collection of print resources. Procedures must be in place to document the circumstances under which library journal articles may be made available via the Loansome Doc service. Conditions of the service are set by the Library's Interlibrary Loan Policy, The Loansome Doc Contractual Agreement, and by Copyright Law (Title 17, US Code).

DEFINITIONS

Interlibrary Loan	The practice of providing requested library materials to eligible borrowers
ILLiad	An Interlibrary Loan management system that is used to facilitate borrowers' requests.
Loansome Doc Service	Service that allows PubMed users to order full-text copies of articles from a medical library.
Loansome Doc Contractual Agreement	Form that must be completed by individuals who wish to register to use the service.

PROCESS & PROCEDURES

Loansome Doc requests are initiated by requestors using PubMed:

- Requestor contacts the Greenblatt Library to request Loansome Doc Service.
- Requestor completes and returns the Loansome Doc Contractual Agreement.
- Requestor creates an account within the Interlibrary Loan system at <http://augusta.illiad.oclc.org/illiad/Logon.html>
- Requestor searches and marks citations for requesting/ordering articles.
- Requestor logs into their Loansome Doc account to place the order for articles.

Interlibrary Loan staff receives incoming Loansome Doc Requests.

Interlibrary Loan staff processes articles and posts to requestor's Interlibrary Loan account.

Requestor is notified, via e-mail, of the availability of the requested article.

Requestor logs into their Interlibrary Loan account to retrieve article.

Requestor receives monthly invoice representing articles requested/filled.

Responsibilities

The responsibilities each party has in connection with ARSA Policy 8.04, Interlibrary Loan (Loansome Doc) Policy, are:

Requestor	Responsible for completing Contractual Agreement, requesting article, and providing payment for a completed request.
Interlibrary Loan Unit	Responsible for processing all incoming Loansome Doc requests.
Lending Library	Responsible for accepting requests and sending requested articles to the Greenblatt Library for processing for the Loansome Doc Customer.
