# **Family Medicine**

## 1. Medical Knowledge

Goal Statement: Medical students are expected to master a foundation of clinical knowledge with integration of basic sciences and the translation of that knowledge to the clinical setting.

1.5 Demonstrate comprehension of clinical interventions and agents including pharmaceutical, surgical, genetic, complementary and alternative medicines, and other therapies.

Family Medicine Clerkship students will familiarize themselves with therapeutics and other clinical interventions encountered during their patient experiences with directed independent study of those therapeutics identified by the Clerkship faculty as most pertinent to the practice of Family Medicine in the MCG curriculum objectives. This objective includes demonstration of therapeutic prescribing and diagnostic study ordering with preceptor review and feedback. Ongoing evaluation of experiences is accomplished through patient encounter documentation and its use for real time course management and ongoing curricular evaluation and development.

1.6 Demonstrate knowledge and ability to interpret epidemiological and public health contributions to understanding health and disease.

Evaluative learning is provided through the Population Based Care weekly learning module to facilitate student performance on the summative NBME subject examination.

1.7 Demonstrate knowledge of preventive medicine and current guidelines for health promotion and disease screening.

Family Medicine Clerkship students are expected to maintain a focus on preventive care in all patient encounters when appropriate. Faculty evaluation of student understanding and application is provided through feedback from individual preceptor(s).

#### 2. Patient Care

Goal Statement: Medical students, as members of the healthcare team, are expected to provide patient and family centered care that is compassionate and effective for the promotion of health and the management of illness.

Such histories should consider the age, gender, culture, family and social dynamics of the patient where appropriate as well as use of therapeutics outside of those prescribed. Assessment of student performance will be performed by the students' preceptor as part of their formative and summative evaluations.  |

Additional requirements of the clerkship include observation of performance of a focused HEENT examination and musculoskeletal examination with documentation of completion by their preceptor for entry into One45. This represents a minimum requirement of the clerkship to meet expectations.  |

[procedures determined by core clerkships]   | Family Medicine Clerkship students are expected to participate in all available procedural opportunities as part of their clinical experience. They are required to complete those procedures identified by the MCG curriculum specific to the Family Medicine Clerkship which are three (3) finger stick blood glucose measurements and writing a prescription with documentation of completion of this task by their preceptor on the procedure card for entry into One45. This represents a minimum requirement of the clerkship to meet course expectations.  |
| 2.5 Construct a differential diagnosis for common clinical presentations.  | Family Medicine Clerkship students will demonstrate an ability to formulate a differential diagnosis for the common presenting clinical conditions encountered in the Family Medicine setting. This will be evaluated through students' clinical presentations to their preceptor and their preceptor's evaluation of their written documentation of patient encounters. Attention should be paid to an appropriately inclusive but not unwieldy differential and an ability to appropriately triage the differential that supports appropriate, cost efficient, and timely evaluation while partnering with patients to meet their expectations. 3.4 Develop clinical questions related to patients' problems and demonstrate skills to find evidence that is relevant and valid information to answer clinical questions using medical information technology.

Family Medicine Clerkship students are expected to demonstrate competency in effectively and efficiently searching the medical literature and other point-of-care resources to assist in formulation of differentials, determining the most likely or definite diagnosis based on presenting signs and symptoms and convey this information through oral presentation and/or written notes. Evaluative learning is accomplished through the Population-Based Care weekly quiz which includes items on sensitivity, specificity and strength of evidence of study types. Assessment of student performance will be performed by the students' preceptor as part of their formative and summative evaluations.

#### 4. Communication

Goal Statement: Medical students are expected to demonstrate skills that result in effective communication and collaboration with patients, families, and professional associates.

Core Competencies: Graduates from the Georgia Regents University - Medical College of Georgia will be able to:

| 4.3 Demonstrate the ability to give a clear, concise, and organized oral presentation and written documentation of a history and physical exam with basic elements of assessment and a plan that addresses the psycho-social and biomedical needs of the patient for a focused or complete patient encounter | Family Medicine Clerkship students are expected to be able to obtain and convey an appropriate history and physical exam through verbal and written medium. Students are expected to develop basic assessments with evaluative, therapeutic and other management plans as appropriate for their level of training that includes not just the biomedical but also psycho-social needs of the patient that are appropriately complete or focused as the situation requires. Assessment of student performance will be performed by the students' preceptor as part of their formative and summative evaluations.  |

| 4.4 Conduct an interview with a limited English-speaking patient through appropriate use of an interpreter.  | Family Medicine Clerkship students may encounter patients with limited English-speaking proficiency requiring use of an interpreter or other culturally and linguistically appropriate services as dictated by current policy and regulation. Availability and provision of these services are variable by clinical site. Students should avail themselves of opportunities to participate in these encounters when feasible utilizing previous educational experiences in the pre-clerkship year in order to develop proficiency. Assessment of student performance will be performed by the students' preceptor as part of their formative and summative evaluations. |
| 4.5 Recognize barriers to effective communication and implement strategies to overcome these barriers (e.g. health literacy, vision/hearing impairment, disabled, pediatric, geriatric).   | Family Medicine Clerkship students should remain cognizant of potential barriers to communications and implement strategies to overcome barriers such as, but not limited to, health literacy, vision or hearing impairment, disability, pediatric and geriatric patients. Identification or such barriers and appropriate modifications to interactions and management should be included in presentations. Assessment of student performance will be performed by the students' preceptor as part of their formative and summative evaluations.   |

Failure to meet these requirements will result in inability to sit for the NBME subject examination and result in an incomplete for the Clerkship until appropriate remediation is completed. Failure to comply may be construed as a failure to meet expectations for Professionalism by the students' faculty member and be reflected as such on their clinical evaluation.                                |

This would include: 5.4.1 Describe personal responses to stress and employ appropriate stress reduction interventions as needed. | Family Medicine Clerkship students will receive Mid-Rotation Feedback at a minimum that affords students an opportunity to self-reflect on their Professionalism, Communication, Interpersonal and Collaborative Skills (among other domains) and receive feedback from the faculty they are working with. Student response to this reflection and feedback will be assessed as part of the summative clinical faculty evaluation.   |

5.5 Demonstrates sensitivity and responsiveness to a diverse patient population, including but not limited to diversity in gender, age, race, religion, disabilities and sexual orientation and investigate impact of those on clinical care and medical decisions.

Family Medicine Clerkship students are exposed to patients across the entire lifespan, multiple genders, races, sexual orientation and with varying degrees of debility. As part of their history taking students are expected to explore these elements and how consider them in their deliberations on their care and decision making. Assessment of student performance will be performed by the students' preceptor as part of their formative and summative evaluations.

#### **6. Systems-based Practice**

Goal Statement: Medical students are expected to develop an awareness of available health care system resources and demonstrate an ability to use them appropriately to provide optimal quality patient care.

Core Competencies: Graduates from the Georgia Regents University - Medical College of Georgia will be able to:

Student derived management plans are expected to be inclusive of their role and impact that all team members play and the dynamics they have from the perspective of a Primary Care physician. Assessment of student performance will be performed by the students' preceptor as part of their formative and summative evaluations. |
| 6.2 Examine medical errors and quality problems using a health systems approach and describe available methods to minimize them.  | Students on the Family Medicine Clerkship are required to complete a Quality Assessment (QA) tool looking at evidence based care measures for a pre-defined condition or population as an exercise in future activities they will be involved in as a health professional and to serve as an instructional tool for condition or population specific quality measures and to serve as a discussion point for the faculty they are working with.  |
