ACCELERATED/DUAL SUPPLEMENTATION IMPLEMENTATION

Definitions

- Accelerated Single Degree Program: also referred to as a fast track program, is simply defined as post-secondary program that offers intense courses that take less time to complete.
- Accelerated Dual Degree Program: also referred to as a Bachelor’s to Master’s track or a Master’s track to Professional track, this type program allows students the opportunity to complete two degrees at an accelerated pace. A Bachelor’s Track to Master’s Track allows an undergraduate student to take graduate level classes and use them to fulfill undergraduate requirements. The Bachelor’s Track to Professional track allows professional level coursework to be used to fulfill the final year of undergraduate requirements.
- Dual Degree Program: programs that enable eligible students to be enrolled in two degree programs to complete work toward an additional degree program but the time to completion is the same as if they were to take them separately. Example MD/PhD
