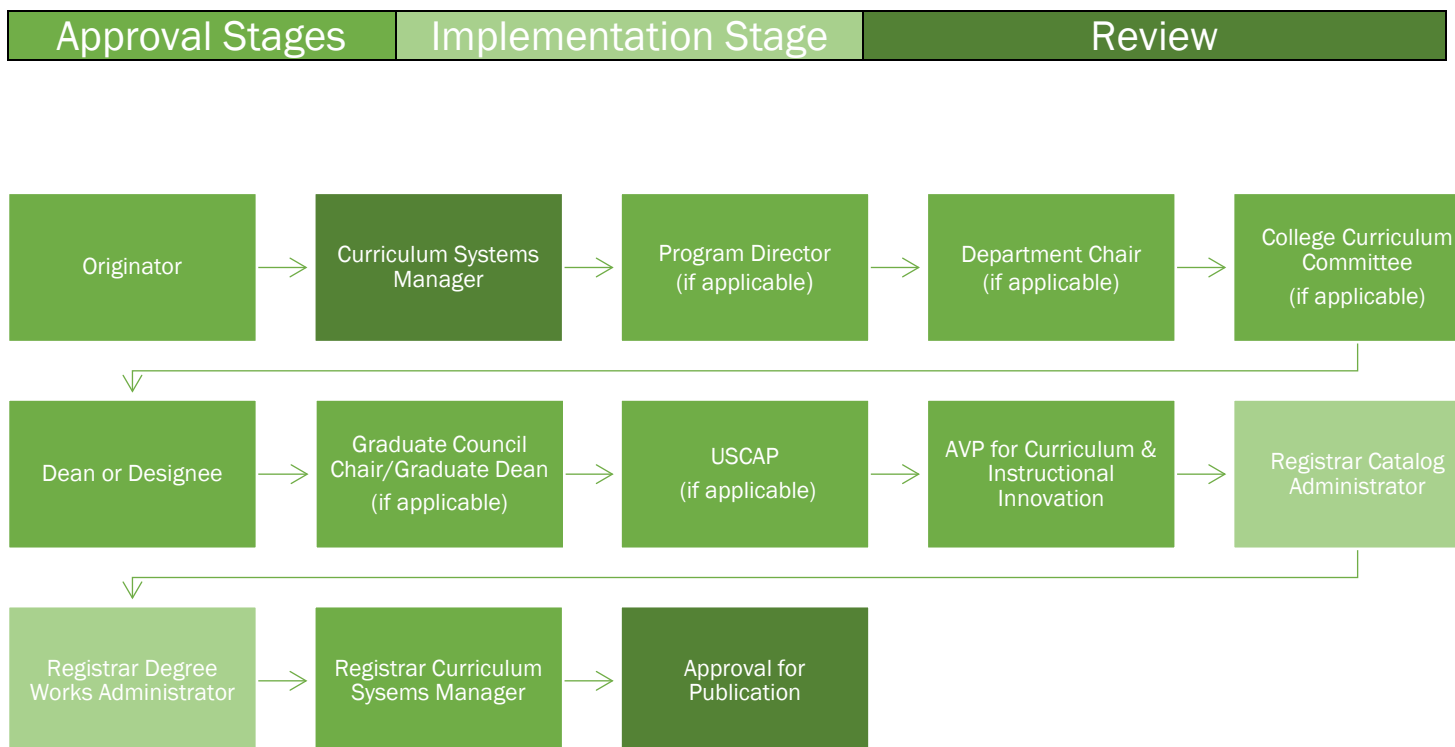

Please note, if these course inactivation's result in a change of requirements for a degree program, a Program Revision will also need to be launched. 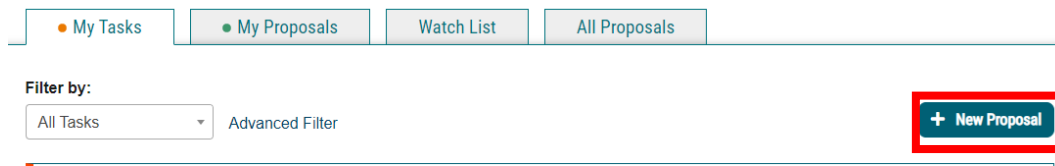

COURSE MASS INACTIVATION PROPOSAL INSTRUCTIONS

1. Login to Curriculog using your net ID and password.

2. Select “New Proposal” from the task menu.

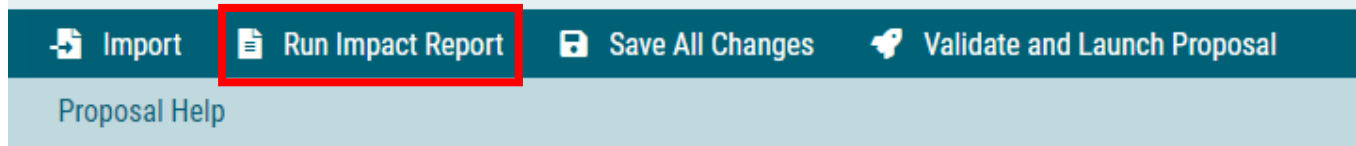


3. Hover over the proposal titled “Course: Mass Inactivation” and click the blue check mark in order to begin.

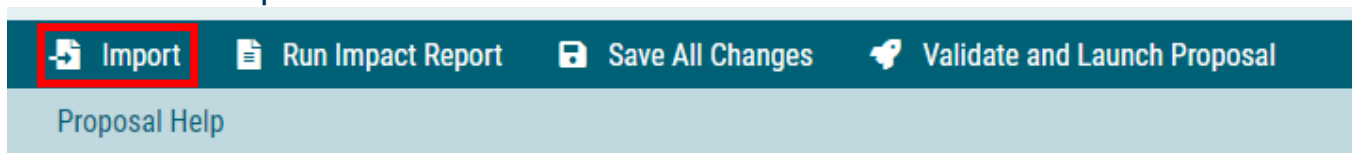




