

TITLE IX SEXUAL MISCONDUCT REPORTING/OPTIONS

**I: To file CRIMINAL REPORT:
AUGUSTA UNIVERSITY POLICE
Emergency 706-721-2911**

Non-emergency 706-721-2914

- ◆ If the incident occurred on Augusta University property, report to Augusta University Police, who will refer the incident to the Title IX Coordinator for options, support and Title IX information/investigation.
- ◆ If the incident occurred off campus, call local law enforcement to file criminal complaint and contact the Title IX Coordinator.

II. To file report with TITLE IX:

You may file a report by contacting the Augusta University Title IX Coordinator (706-721-0901) or by emailing micreed@augusta.edu

If you are filing a report, you will not be required to participate with the process, however, Title IX policy and procedures require Augusta University to investigate when the allegation is serious in nature and potential harm to individual or University

III. Remain CONFIDENTIAL:

Schedule an appointment by contacting Student Counseling and Psychological Services at 706-737-1471

IV. To file ANONYMOUS OR THIRD PARTY REPORT:

IF YOU WITNESS AN INCIDENT RELATED TO SEXUAL MISCONDUCT, DATING/ DOMESTIC VIOLENCE:

Report the incident immediately to Augusta University Public Safety and/or the Title IX Coordinator either by telephone, in person or by email. You may report anonymously.

Note Augusta University Employees have a responsibility to disclose any Title IX incident to the Title IX Coordinator.

AMNESTY

To encourage reporting, any victim and witness who reports a sexual misconduct incident will not be found responsible for any University alcohol or drug violation which may have occurred during the incident.

Know Your Rights: Sexual Misconduct

VICTIM RESOURCES

Effective Consent

CONSENT CANNOT BE GAINED THROUGH:

- **FORCE:** By ignoring or acting in spite of objections of another
- **COERCION or INTIMIDATION:** Implied threat involving repeated pressure and harassment
- **INCAPACITATION:** When the respondent knows or reasonably should have known of such incapacitation. The “who, what, when,



All persons have the right to feel respected, acknowledged, and safe during sexual

Effective Consent

Words or actions that show a knowing and voluntary willingness for mutually agreed upon sexual activity

Past consent does not imply present or future consent

Silence or absence of resistance does not imply consent

Consent can be withdrawn at any time
